Sehubungan dengan disetujuinya Perubahan Peraturan Tata Tertib tentang Pasar Fisik Timah berdasarkan Surat Bappebti No.141/BAPPEBTISD/05/2018 perihal Persetujuan Perubahan PTT Pasar Fisik Timah Murni Batangan tertanggal 31 Mei 2018, maka dengan ini Bursa Komoditi dan Derivatif Indonesia ("Bursa") menetapkan hal-hal sebagai berikut:

In connection with the approved Revision on Rules and Regulations regarding Tin Ingot Physical Market by virtue of COFTRA Letter No.141/BAPPEBTISD/05/2018 regarding Approval of Revision on the Rules and Regulation of Tin Ingot Physical Market dated 31st May 2018, thus Indonesia Commodity and Derivatives Exchange (the "Exchange") stipulates the following provisions:

1. Memberlakukan Perubahan PTT Pasar Fisik Timah Murni Batangan terhadap transaksi perdagangan timah murni batangan terhitung dari tanggal efektif Surat Edaran ini. Untuk itu, Anggota Bursa harus mematuhi Perubahan PTT Pasar Fisik Timah Murni Batangan tersebut diatas.
1. To implement the Revision on the Rules and Regulation of Tin Ingot Physical Market as of the effective date of this Joint Circular Letter. Therefore, Members of the Exchange must comply with the aforesaid Revision on the Rules and Regulation of Tin Ingot Physical Market.
2. Dengan penerapan Perubahan PTT tentang Pasar Fisik Timah, maka PTT tentang Bab 24 Kontrak Fisik Timah Murni Batangan sebelumnya dinyatakan tidak berlaku.
2. By implementing the Revision on the Rules and Regulation regarding Tin Ingot Physical Market, hence the previous Rules and Regulation regarding Chapter 24 of Tin Ingot Physical Contract shall cease to be in effect.

II. KETENTUAN LAIN

1. Ketentuan dalam Surat Edaran Bersama ini berlaku efektif sejak tanggal ditetapkan.

II. MISCELLANEOUS

1. The provisions set forth in this Joint Circular shall be effective on the date of stipulation.

2. Dengan efektifnya Surat Edaran ini, maka Surat Edaran PT BKDI NO. 022/SE-DIR/BKDI/VII/2015 mengenai Pemberlakuan PTT BKDI Bab 24 tentang Kontrak Fisik Timah Murni Batangan tertanggal 31 Juli 2015 dicabut dan dinyatakan tidak berlaku.
2. With the effectiveness of this Joint Circular, hence Circular Letter of ICDX Number 022/SE-DIR/BKDI/VII/2015 dated 31 July 2015 regarding the Implementation of Rules and Regulation BKDI Chapter 24 concerning Tin Ingot Physical Contract is revoked and cease to be in effect.
3. Ketentuan-ketentuan dalam Surat Edaran Bersama ini dapat diubah dari waktu ke waktu.
3. Provisions as referred to in this Joint Circular are subject to change from time to time.

Demikian Surat Edaran Bersama ini agar dapat dipedomani dan dilaksanakan sebagaimana mestinya.
